**E*TRADE FINANCIAL CORPORATION REPORTS
MONTHLY ACTIVITY FOR FEBRUARY 2015**

NEW YORK, March 13, 2015 – E*TRADE Financial Corporation (NASDAQ: ETFC) today released its Monthly Activity Report for February 2015.

Daily Average Revenue Trades (“DARTs”) for February were 179,420, a four percent increase from January and an 11 percent decrease from the year-ago period. The Company added 37,224 gross new brokerage accounts in February, ending the month with approximately 3.2 million brokerage accounts — an increase of 20,715 from January.

Net new brokerage assets were \$1.7 billion in the month. During the month, customer security holdings increased by six percent, or \$12.2 billion, and brokerage-related cash increased by \$2.1 billion to \$42.1 billion. Bank-related cash and deposits increased by \$0.1 billion, ending the month at \$5.8 billion. Customers were net sellers of approximately \$0.8 billion in securities during the month.
